PROVINCIAL ORDINANCE NO. 2017-007

AMENDING THE RATES OF SECRETARY'S FEES ON ISSUANCE OF CERTIFICATIONS AT THE PROVINCIAL ASSESSOR'S OFFICE.

"WHEREAS, one of the mandated duties of the Office of the Provincial Assessor is to issue upon request by any interested party, certified copies of assessment records and all other records relative to assessment, upon payment of service fee to the Provincial Treasurer's Office;

"WHEREAS, the existing rate of secretary's fee for the issuance of certifications is already outdated and the cost of the delivery of the service at present rate is already impractical;

"WHEREAS, the issuance of some certifications, particularly the history of real property tax assessments, as well as the verification of old records, need longer time, hence, the necessity to impose a graduated rate according to the age of the assessment records;

"WHEREFORE, be it ordained by the Sangguniang Panlalawigan of Bohol in session duly assembled –

"SECTION 1. **Amendment.** – The following are the rates on the issuance of certified copies of assessment records, to wit:


