PROVINCIAL ORDINANCE NO. 2017-008

SETTING THE RATE OF MARK UP ON THE COST OF ACCOUNTABLE FORMS SOLD TO THE MUNICIPAL LOCAL GOVERNMENT UNITS AND OTHER AUTHORIZED AGENCIES.

"WHEREAS, the Provincial Government of Bohol (PGBh) is regularly engaged in the purchase of Accountable Forms with or without face value at the National Printing Office for the needs of both Provincial and Municipal Governments;

"WHEREAS, the amount allocated for the purchase of the accountable forms is considerably a huge amount under the regular budget of the Provincial Government particularly the office of the Provincial Treasurer which is the office responsible in the management and control of accountable forms that affect the allocation of funds for the priority programs/projects of the PGBh;

"WHEREAS, the recovery of the cost of accountable forms, delivery cost, packing fee and other related expenses incurred in the purchase of the accountable forms is necessary to maintain cash availability;

WHEREFORE, be it ordained by the Sangguniang Panlalawigan of Bohol in session duly assembled -

"SECTION 1. **Title.** – Setting the Rate of Mark Up Equivalent to Ten (10%) Percent of the Cost of Accountable Forms purchased from the National Printing Office except Accountable Form No. 56 (Real Property Tax Receipt) which will be sold at cost only and a Packing fee of Ten (P10.00) stubs purchased.

"SECTION 2. **Coverage.** – The imposition of (10%) mark up will cover to accountable forms enumerated hereunder, to wit:

1. Accountable Form No. 51 (Official Receipt)
2. Accountable Form No. 52 (Certificate of Record of Transfer of Large Cattle)
3. Accountable Form No. 53 (Certificate of Ownership of Large Cattle)
4. Accountable Form No. 54 (Marriage License)
5. Cash Tickets (P5.00 Denomination and P2.00 Denomination)
6. BIR Form No. 0016 Community Tax Certificate (Individual)
7. BIR Form No. 0017 Community Tax Certificate (Corporate)

"SECTION 3. **Sponsorship, Co-sponsorship, and Deliberation.** – This ordinance was sponsored by Hon. Elpidio M. Jala; co-sponsored by Hon. Tomas D. Abapo, Jr., and the Honorable Presiding Officer, Atty. Venzencio B. Arcamo, and duly deliberated by all Members present.

"SECTION 4. **Effectivity.** – This ordinance shall take effect immediately."


