Note: The following scheme of payments are as follows:

- 1. Those consumers consuming 30 cubic meters or less shall pay the retroactive charges spread into 60 months or 5 years, so as not to feel the burden of paying this VAT charges;*
- 2. Those consumers consuming more than 30 cubic meters, the period of paying shall be spread into 36 or 48 months depending on the number of cubic meters of water consumed*
